It has been a busy year in Massachusetts relative to environmental permitting. Regulatory efforts have focused on climate change adaptation and on renewable energy and greenhouse gas reduction, including tax incentives for solar, wind and offshore wind, DEP initiatives in combined heat and power and anaerobic digestion, and changes to MEPA regulations to meet the Commonwealth's greenhouse gas reduction policies. In addition, the past year has seen numerous casino proposals make their way into the permitting process.
