About the Conference

The past few years have seen important shifts in the Supreme Court which, along with the Biden Administration's environmental priorities, gives us much to address at this year's Santa Fe conference.

We will open with John Cruden, Beveridge & Diamond, and Jordan Diamond, ELI, discussing the changing landscape of environmental law and executive powers within the Biden Administration. From there, we have two panels evaluating the impact of the Supreme Court's shifting majority on environmental cases and the broader implications for NRD matters and matters arising under the CWA, OPA and federal jurisdiction broadly.

Another panel is dedicated to the landmark case of *West Virginia v. U.S. Environmental Protection Agency*, sometimes described as the case about nothing where everything is at stake. You will have an opportunity to hear from Lindsay See, West Virginia Solicitor General, who presented West Virginia's arguments at the Supreme Court, and Kevin Poloncarz, who argued for the Power Companies Climate Coalition and a number of individual utilities supporting the EPA.

Turning from the Supreme Court, Co-Chair Bill Jackson will be joined by state and Tribal representatives to discuss the increasing powers and roles of states and Tribes for addressing natural resource damages. Robert Bilott, and other leading PFAS practitioners, will offer perspectives on the latest PFAS regulations, litigation of PFAS claims, and the intersection of PFAS contamination and NRD.

Finally, you will hear from Maxine McReynolds with the Los Alamos National Laboratory on their approach to government-to-government Tribal consultation and the Laboratory's work pursuant to the National Historic Preservation Act. She will be joined by Co-Chair Sarah Bell, Ted Tomasi with Integral and Bob Unsworth with

IEc to update you on the latest technical tools for addressing cultural resource damages plus NRD assessment, remedies, and restoration projects for human uses, along with Brian Israel, who will offer the latest perspectives on trying an NRD case
